The file has been received by way of transfer from the Court of Ms. Surya Malik Grover, Learned Joint Registrar (Judicial)-4, as per circular dated 25.05.2022 of Deputy Registrar (Original), reference:- Roster of the Joint Registrar (Judicial) w.e.f 31.05.2022.

IA No. 13401/2018 (application filed by the plaintiff u/O XXII Rule 4 CPC r/w Section 151 CPC seeking impleadment of LR's of deceased defendant no.5)

Reply has already been filed by LR's of deceased defendant no.5.



Learned counsel for the plaintiff has stated that he has mentioned the names of only one set of LRs of deceased defendant no.5 and other LRs may be directed to mention the details of names and addresses of all the remaining LRs of deceased defendant no.5.

Learned counsels for the non-applicants have stated that there are two sets of LRs of deceased defendant no.5 and there is settlement between both sets of LRs of deceased defendant no.5 to contest the case jointly. Both learned counsels for non-applicants/respondents have undertaken to file copy of the settlement and details of names and addresses of all the LRs of deceased defendant no.5 alongwith their ID proofs that they are entitled to be impleaded as LRs of deceased defendant no.5.

IA No. 16789/2021 (application filed by the plaintiff u/O XXII Rule 4 CPC r/w Section 151 CPC seeking impleadment of LRs of deceased defendant no.1)

Learned counsel for the plaintiff has stated that LRs of deceased defendant no.1 are already party to the suit property as defendant nos. 2,3,5,6 and 7.
