1. An affidavit dated 10.04.2026 has been filed by the Deputy Secretary, Ministry of Home Affairs, Government of India [in CONT. CAS(C) 1995/2024] wherein it has been averred as under: -

“6. The Answering Respondent most respectfully submits that as per the assessment received from various CAPFs, the approximate financial implication is as follows:-

CISF	Rs. 7,57,711/-	Rs. 1,50,10,24,675/-
CRPF	Rs. 89,92,52,988/-	Rs. 60,41,24,56,608/-

TOTAL	Rs. 98,15,61,311/-	Rs. 66,83,89,46,135/-

7. The Answering Respondent most respectfully submits that the Review Petition has been filed vide diary number 9504/2026 before the Hon'ble Supreme Court against the order dated 18.08.2025, and the same is pending adjudication on one of the grounds that in a similar matter bearing civil appeal no. 2010 of 2009 between ALL INDIA POSTAL EMPLOYEES UNION VERSUS UNION OF INDIA & ORS, Hon'ble Supreme Court, vide its order dated 07th May, 2015, set aside the order of High Court and directed respondents to give notional monetary benefits and granted relief to UOI from paying any arrears of wages/ salaries. It is most respectfully submitted that since the Review Petition is pending before the Hon'ble Supreme Court, considering the issues which have a direct bearing/impact to the present proceedings. It is further respectfully submitted that the defects have been removed on 23.03.2026 and the same is likely to be listed shortly thereafter.

8. The Answering Respondent most respectfully submits that the matter involves a policy decision having an effect across CAPFs. Pursuant to the observations received from the Ministry of Finance vide email dated 02.04.2026, a committee



*has been constituted to look into the financial implications and also to satisfy the query of the Ministry of Finance. An office order dated 09.04.2026 is marked and annexed herewith as **ANNEXURE III**.*

2. The respondents are directed to expedite the exercise as referred to in the aforesaid affidavit.
3. Let a fresh status report be filed before the next date of hearing.
4. List for further consideration on 29.07.2026.
5. The personal appearance of concerned officials is dispensed with for the next date of hearing. However, they are directed to join the proceedings virtually on the next date of hearing.
