1. Learned counsel for the Union of India cites lack of funds as the impediment for non-compliance with the directions contained in the orders dated 14.08.2024 passed in W.P.(C) 1022/2023 and Connected Matters; 26.07.2024 passed in W.P(C) 10238/2024; 30.08.2024 passed in W.P (C) 12043/2024; 10.09.2024 passed in W.P (C) 12684/2024 and 10.09.2024 passed in W.P (C) 12678/2024.
2. On a pointed query as to the date on which the requisite sanction of funds / allocation of budget was sought, the answer is nebulous.
3. In the circumstances, the concerned DIG, Personnel, DTE, CRPF is directed to file an affidavit as to the date on which the request for allocation of budget was made for the purpose of implementation of the said judgment. Relevant correspondence issued in this regard with the Ministry of Finance/ Ministry of Home Affairs, Government of India shall also be placed on record. Let the same be filed within a period of one week from today.
4. A corresponding affidavit shall also be filed by the concerned DIG Personnel, CISF.
5. The aforesaid affidavits shall also clearly indicate the financial outlay required for implementation of the aforesaid judgment.
6. The Ministry of Finance (through Secretary, Department of Expenditure) is impleaded as the respondent in the present petitions.
7. Let an amended memo of parties be filed by the petitioner within a period of one week from today.
8. The concerned officials of Ministry of Home Affairs and the



Department of Expenditure, Ministry of Finance are requested to join the proceedings virtually on the next date of hearing and apprise this Court as to the time frame for allocation of the requisite financial outlay.

9. DIG, Personnel, DTE, CRPF, who is present in the Court, submits that he shall take instructions as to whether arrangement can be made for making requisite payment for the petitioners for now, while pursuing for allocation of budget for those personnel who have not yet approached this Court.
