1. Ld. Counsel for defendants no.1 and 2 has submitted that he has filed separate vakalatnamas on behalf of defendant no.1 vide diary no.1502146/2025 and on behalf of the defendant no.2 vide diary no.1502366/2025. However, the same are not on record. Let appropriate steps be taken as per law.
2. No written statement, affidavit of admission/denial of documents and reply to the captioned IAs has been filed on behalf of defendants no.1 and 2. Time sought. Let the



same be filed as per law with advance copy to the plaintiff, who may file replication alongwith affidavit of admission/denial of documents and rejoinder qua the captioned IA thereafter as per law.

The defendants no.3 & 4 shall file their written statement, affidavit of admission/denial of documents and reply to the captioned IAs within 30 days from the date of service with advance copy to the opposite party, who may file replication, rejoinder to the captioned IA and affidavit of admission/denial of documents thereafter within 30 days.
6. Let the pleadings be completed as per law.
7. Re-notify the present matter for completion of service, completion of pleadings and further proceedings on 27<sup>th</sup> May, 2025.
