1. Issue notice.
2. Ld. Counsel for defendants no. 1 & 2 accepts the notice and submits that he has no objection to the captioned IA.
3. Heard. Record perused. It appears that summons could not be served upon the defendants no. 3 and 4 through ordinary mode. For the reasons stated in the application and in view of submissions, let defendants no.3 and 4 be served with summons of the suit and notice of the pending applications through substituted service i.e. by way of publication in newspaper 'Indian Express' (English edition) and 'Jan Satta' (Hindi edition) having circulation in New Delhi on filing of PF and subject to deposit of necessary publication charges by petitioner, as per rules, returnable on next date of hearing.
