Exemption, allowed subject to all just exceptions.

The application stands disposed of.

Crl. M.A. No.4261/2017

Learned counsel for the petitioner submitted that he wants to withdraw the present application; wherein the petitioner has prayed for stay of the operation of the order dated 20.02.2017 passed by the ACMM, South, Saket Court, New Delhi in CC No.473636/16, with liberty to file a fresh application challenging the same.

The application is dismissed as withdrawn with liberty as prayed for.

Crl. M. A. No. 5748/2017

This is an application filed by respondent No.2 seeking recall of the *ex parte* order dated 14.03.2017. In this application respondent No.2 prayed in respect of prayers 'c', 'd' and 'e' as follows :-

“(c)Exercise power under Section 94 of the Cr.P.C. and direct the Police to seize the documents listed as document Nos. 1-25 at para 7 above forthwith, and send them for forensic analysis to an ISO-approved CFSL Laboratory for determination of the year in which they have been brought into existence.

(d) Direct Connaught Plaza Restaurants (P) Ltd. and the other 4 Directors of Connaught Plaza Restaurants (P) Ltd (namely, Ms. Aysel Melbye, Mr. Manish Yadav, Mr. C. R. Dua and Mr. Ravi Oberoi, viz. Non-applicant Nos. 3-7) to certify that documents Nos. 1-25 listed in para 7 above are part of their Company’s legitimate records within 1 week of such direction being issued by this Hon’ble Court, or within such other short time this Hon’ble Court deems fit.

(e) Summon Sumeer Bedi (Non-applicant No.8) to depose in Court under oath that the signatures appended to document Nos. 1-9 are his, and subsequently, send the original signatures to CFSL for verification also on this count.”

Notice.

Mr. Harsh Bora, Advocate accepts notice on behalf of the petitioners and states that he has not received the copy of the application. A copy of the application has been supplied to the counsel for the petitioners by the respondent No.2 in court today. Reply be filed within four weeks. Rejoinder, if any, be filed within four weeks thereafter.

Crl. M. A. No. 4262/2017 (stay) and CRL.M.C. 1018/2017

Respondent No.1 is directed to file a status report before the next date

of hearing. Reply be filed by respondent No.2, within four weeks. Rejoinder, if any, be filed within two weeks thereafter.

Learned counsel for both the parties submits that no other miscellaneous application is pending.

The date already fixed, i.e. 21.09.2017 stands cancelled. Renotify on 03.07.2017.
