Ld. counsel for the defendant no. 13 submits that the
defendant no. 13 has filed the compliance-affidavit, vide diary no.



1905166/2025 way back in March, 2025. Official noting also shows the same that the defendant no. 13 has filed the compliance-affidavit.

No written statement has been filed by the defendant no. 1 to 10 & 14 to 23 (*Refer: Order dated 09.05.2025*), though they were served on 14.02.2025, therefore the prescribed time period to file their written statements has expired. Accordingly the right of the defendant no. 1 to 10 & 14 to 23 to file their written statements is closed.

The defendant no. 27 is John Doe.

The defendant nos. 28 to 38 were served on 07.03.2025. (*Refer: Order dated 09.05.2025*), the prescribed time period to file their written statements has expired, therefore the rights of the defendant nos. 28 to 38 to file their written statements is closed.
