Let the affidavit of admission/denial qua statement of account be also filed by the defendant no.2 within two weeks with advance copy to the opposite side. This document however will be deemed admitted by the defendant no.1 in view of Chapter VII Rule 4 of Delhi High Court (Original Side) Rules, 2018.
 6. Joint Document Schedule, including hard copy of the same, be filed by the parties at least two weeks before the next date.
 7. Re-notify the matter for carrying out remaining admission/denial and for marking entries in the Joint Document Schedule on **27th April, 2022.**
