1. Vide order dated 25.03.2026, learned counsel for Defendant Nos. 1 and 3 had submitted that they had no objection if the captioned application was allowed.

2. As per the office note, no reply has been filed till date. Vide order dated 25.03.2026, a last and final opportunity had been granted to the non-applicant to file the reply despite multiple opportunities having already been granted.

3. Considering the facts and circumstances of the case, the right of the non-applicant to file the reply is closed.
