It is submitted by counsel for proposed LR's of respondent no.4 that he has no objection, if the present application is allowed. It is further submitted by him that he has already filed vakalatnama on behalf of proposed LR's of respondent no.4 and seeks some time to file vakalatnama on behalf of fourth proposed LR of respondent no.4 namely Vikash Khanna. Let the same be filed on or before next date of hearing. He is directed to file hard copy of vakalatnama filed on behalf of proposed LR's of respondent no.4 before registry, if not filed earlier.

It is submitted by counsel for petitioner that he has already filed amended memo of parties vide diary no. E-44549/2023 dated 11.01.2023. However same has not come on record. He is directed to check with the registry. It is further submitted by counsel for petitioner that death certificate refiled on behalf of petitioner is still lying under objection and he is trying to remove the same.
