1. Matter is listed for completion of service and pleadings.
2. Amended memo of parties filed on behalf of plaintiff is on record.
3. As per the report of registry, process sent to Defendant no.



- 3 and 4 has been received back unserved.
4. Defendant no. 5 has been served through ordinary mode on 23.02.2026. Defendant no. 10 and 11 have been served on 11.02.2026 through ordinary mode. Let written statement, if any be filed as per rules.
 5. Service report of remaining defendants is still awaited.
 6. Defendant no. 13 is a John Doe.
 7. Ld. Counsel for defendant no. 4 has entered appearance on behalf of defendant no. 4 and submits that they were served on 15.02.2026. Ld. Counsel for plaintiff submits that they are not disputing the date of service but defendant no. 4 must comply with the directions of Hon'ble Court. Ld. Counsel for defendant no. 4 submits that their client is based in United States, due to which they need some more time to comply with the directions of Hon'ble Court. Defendant no. 4 is directed to file the requisite details within two weeks alongwith its affidavit of compliance.
 8. Ld. Counsel for defendant no. 9 and defendant no. 10 have entered appearance today.
 9. Ld. Counsel for plaintiff further submits that they shall take fresh steps for service of defendant no. 3 META. Let necessary steps be taken within a week for service of defendant no. 3 on filing of process fee.
 10. Ld. Counsel for plaintiff submits that defendant no. 5 has complied with the directions of the Court. Ld. Counsel for defendant no. 5 LinkedIn submits that they shall be filing their affidavit of compliance within a week.
 11. Ld. Counsel for plaintiff submits that there has been no response from defendant no. 6 GoDaddy.com and the impugned websites are still operating. Ld. Counsel for



GoDaddy has entered appearance today and submits that they shall be complying with the directions within two-three weeks and file their affidavit of service.

Counsel for plaintiff submits that directions contained in clause (f) of paragraph 31 of order of Hon'ble Court dated 23.01.2026 have been fully complied with by defendant no. 7 and defendant no. 8 X has also complied with the directions contained in clause (g) of paragraph 31 of order of Hon'ble Court dated 23.01.2026 and has blocked the infringing pages and disclosed BSI details to the plaintiff.
