1. Matter is listed for service status of Defendant no.1 to 3, 7 and 12 / completion of pleadings.
2. Ld Counsel for plaintiff submits that they will take fresh steps for service of summons upon defendant nos. 1, 2, 3, 7 and 12. In view of submissions made, let fresh steps be taken and summons be issued to defendant nos. 1 to 3, 7 and 12 on filing of process fee



within seven days to be served through all permissible modes, returnable on next date of hearing.

3. Compliance affidavits in sealed cover filed on behalf of Defendant no.5 and 6 are on record.

4. Written statement and reply to Injunction Application filed on behalf of Defendant no.8 is also on record. Replication / rejoinder be filed as per timeline already indicated by the Hon'ble Court.

5. Ld counsel for plaintiff submits that defendant no.9 and 10 are *proforma* party.

6. It is submitted by Ld counsel for defendant no.4 that they have already complied with the directions of the Hon'ble Court and they may be deleted from the array of parties. Ld counsel for plaintiff submits that they will seek instructions in this regard. In the meantime, Ld counsel for defendant no.4 is directed to file compliance affidavit within two weeks.

7. Ld Counsels for defendant no.5 and defendant no. 6 submit that they have also complied with the directions of the Hon'ble Court and thus, they may be deleted from the array of parties. Ld counsel for plaintiff objects to the same and submits that further compliances may be required from defendant no.5 and defendant no. 6 as and when any other infringing link is found, hence, they may not be deleted as defendants. However, Ld counsel for plaintiff submits that he has no objection if defendant no.5 and defendant no.6 are exempted from further appearance before the court subject to the condition that they continue to comply with directions as and when passed by the Hon'ble Court.

8. Ld counsels for defendant no.5 and defendant no.6 undertake that defendant no.5 and defendant no.6 shall comply with any



further directions issued by the Hon'ble Court and they may be exempted from further appearance.

9. In view of submissions made by Ld counsel for plaintiff and Ld. Counsels for defendant no.5 and defendant no.6, defendant no.5 and defendant no.6 are exempted from further appearance before the court subject to the condition that they shall comply with any further directions as and when passed by the Hon'ble Court and shall also appear before the court as and when directed to do so.

10. Put up for completion of pleadings on **25.09.2026**.
