1. Writ Petition under Article 226 /227 of Constitution of India read with
Section 528 of B.N.S.S. has been filed on behalf of the Petitioner with the
following prayers:

*“A. Take cognizance of the complaint made to the Registrar
General and Registrar (Vigilance), High Court of Delhi,
seeking institutional scrutiny of the events dated 13.12.2025
after post lunch (14.00 hrs.) B. Call for a factual status
report from the Station House officer, Police station: Anand*



Vihar (Shahdara District), with respect to the police remand application dated 13.12.2025 and subsequent proceedings related thereto/ the events surrounding the police custody remand proceedings;

C. Direct the immediate preservation and production of all relevant CCTV footage of the court premises and chambers, video-conferencing recordings, and other electronic records pertaining to the proceedings conducted on 13.12.2025 (after post lunch – 14.00hrs), to ensure that the truth is institutionally ascertained; and

D. Transfer all proceedings arising out of FIR No. 380/2025 dated 11.08.2025, Police Station Anand Vihar, including but not limited to remand, bail and all ancillary proceedings, from the Courts at Karkardooma, Delhi, to any other competent criminal court outside Karkardooma, preferably Patiala House Courts, New Delhi or Rouse Avenue Courts, New Delhi, in the interest of justice, fairness and to restore confidence in the judicial process.”

2. Status Report be filed in respect of the Application and the proceedings before the learned Trial Court on 13.12.2025. CCTV footage, as sought, be also preserved.
3. Status Report be filed within 15 days with advance copy to opposite counsel.
4. Learned Senior Counsel for the Petitioner submits that amended memo of parties, with accused as party, shall be filed before the next date of hearing.
5. List for consideration on 14.01.2026.
