I.A. 5466/2026 (D No.7) & I.A. 5468/2026 (D Nos. 1,2,5 and 6)

1. This is an application filed under Section 151 of the Code of the Civil Procedure, 1908 ('CPC') by the defendant nos. 7, 1, 2, 5 and 6 for declaring the Local Commissioner's inspection and seizure/sealing action as null and void for the reasons that it was executed beyond the date which was fixed by this Court.

2. For the time being, no notices are being issued in this application.

3. This is an application under Order XXXIX Rule 4 read with Section 151 of the CPC filed by the defendant nos. 7, 2, 5 and 6 seeking to set aside the *ex-parte ad-interim* order dated 19.12.2025 by this Court.

5. Notice accepted by Ms. Nidhi Mohan Parashar, learned counsel appearing on behalf of the plaintiff who seeks and is granted four weeks' time to file reply.

10. Mr. J. Sai Deepak, learned Senior Advocate, on instructions, submits that the defendants are contemplating using the domain name “*www.galypsoworldsourcing.com*” which, according to them, should not violate the interim order dated 19.12.2025 passed by this Court.
11. Ms. Parashar, learned counsel appearing on behalf of the plaintiff registers her objection to this.
12. List on the 23.04.2026 awaiting the Mediation Report.
13. The next date of listing i.e. 22.04.2026 stands cancelled.
14. List before the Joint Registrar for completion of pleadings on 15.04.2026.
