1. This application has been filed by petitioner seeking directions against the respondent.
2. While other aspects of this application will be considered subsequently, *Mr. Mahesh Kabra*/respondent is present on advance notice pursuant to previous order of this Court. It was noted by the Court that visitation to the petitioner has been denied as respondent seems reluctant and his conduct *prima facie* seems like an attempt to ensure that the visitation should not happen.
3. *Mr. Mahesh Kabra* today states that he is willing to get his child to the Children's Room in the Delhi High Court Mediation and Conciliation Centre ('**DHCM&CC**') on *31st May 2025 at 12:00 P.M.*
4. *Ms. Sonam Kabra*/petitioner will be allowed visitation for 3 hours with the child on *31st May 2025 at 12:00 P.M.* uninterrupted by respondent



and if required, presence of the Child Counsellor also be there, in order to make sure that the visitation is unhindered.

5. A copy of this order be sent to Organizing Secretary, DHCM&CC for information and compliance.

6. As agreed in terms of the settlement arrived at between the parties, the *summer vacation visitation* is permitted from 09th June 2025 to 14th June 2025 of the child with the petitioner/mother.

7. Petitioner/mother will pick up the child from the residence of respondent/Mr. Mahesh Kabra on 09th June 2025 at 11:00 A.M. and will return the child on 14th June 2025 at 05:00 P.M.

8. In the period which is otherwise permitted and agreed for i.e. the *summer vacation visitation* and *monthly visitation* (for this month on 31st May 2025), there will be two video calls between petitioner and minor child, in order that the association of the mother with the child remains unsevered; in the opinion of the Court, this is in the best interest of the child.

9. Accordingly, there will be a video call between petitioner and minor child every *Tuesday & Thursday after 08:30 P.M.*

10. In case these compliances are not made by respondent/Mr. Mahesh Kabra, he will have to show cause to the Court as to why he should not be sentenced for deliberate wilful disobedience of the directions of the Court.
