1. This is an application filed under Section 151 of CPC, 1908 seeking direction to the respondent Nos. 2 and 3 to defreeze the bank accounts of the petitioner in view of the No-objection for defreezing of bank/notice under Section 106 BNSS issued to the respondent Nos. 2 and 3 by the Investigating Officer on 04.02.2026.
2. For the reasons stated in the application, issue notice.
3. Mr. Bhalaik, learned counsel accepts notice on behalf of the respondent No. 1 and Mr. Rout, learned standing counsel accepts notice on behalf of the respondent No. 3.
4. The brief facts of the present case are that the accounts of the petitioner i.e., Account No. 922010049915208 with IFSC: UTIB0001771 maintained with Axis Bank and Account No. 3528894521 with IFSC:



CBIN0283384 maintained with Central Bank of India have been freezed based on NCRP / Acknowledgement No. 30207250010245 issued in connection with a cyber-crime complaint.

5. Since a No-Objection Certificate dated 04.02.2026 granted by the Investigating Office, giving no-objection to defreezing of both the accounts of the petitioner, the present application is allowed.

6. In view of the above and the No-Objection Certificate dated 04.02.2026, the accounts of the petitioner i.e., Account No. 922010049915208 maintained with Axis Bank and Account No. 3528894521 maintained with Central Bank of India, if not freezed for any other reason, shall be defreezed immediately.
7. With the said directions, the present petition is disposed of.
8. Accordingly, the next date of hearing i.e., 15.04.2026 stands cancelled.
