1. This court in Writ Petitions being Nos. WP(C) No. 5668/2012,



WP(C) 5664/2013, WP(C) 5668/2013 and WP(C) 5677/2013 by an order dated 08.01.2016 directed the respondent no.3/Shree Geeta Bhawan Model Secondary School to implement the recommendations of the Fifth and Sixth Pay Commissions and release the payments due and payable to the petitioners within six weeks.

2. Admittedly, the payment has not yet been made to the petitioners. It is stated on behalf of the respondent that the school has been closed since 31.03.2015.

3. On 14.12.2017, this court in CONT.CAS (C) 419/2016 has directed as under:-

“Respondents are also directed to file an affidavit as to the constitution of Shree Geeta Bhawan Model Secondary School as to whether it is a society or some other legal entity, which was running the school and managing its bank account (s). Particulars of the bank account being operated by Shree Geeta Bhawan Model Secondary School be also disclosed in the affidavit to be filed. Director (Education) is also directed to ascertain the constitution of Shree Geeta Bhawan Model Secondary School and independently file the actual status, by way of an affidavit, a week before the adjourned date.

List on 8th February, 2018.”

4. Learned counsel for respondent no.1 states on instructions that as of today, an amount of Rs. 37,75,440/- is in their bank accounts which includes an FDR of Rs.7,49,000/-.

6. Learned counsel for the respondent no.1 further submits that after the order dated 14.12.2017 they have made total payment of Rs. 1,86,237/- to all the four petitioners, as per the last drawn salary, for three months. He submits that there were 22 employees (teaching and non-teaching) in the said school which was closed w.e.f. 31.03.2015

and on instructions, he proposes to make the payment of Rs. 5,89,758/- to four petitioners to be shared by them equally in full and final. He states that the remaining amount lying with their bankers shall be paid to other 18 members of the teaching and non-teaching staff.

7. Let the respondent make a proposal in writing by way of an affidavit along with copies of bank statements and FDR within ten days. Response be filed within one week thereafter.

8. Till the next date of hearing, respondents shall not withdraw any amount from the bank accounts.
