4. Learned counsel appearing on behalf of the legal representatives of original respondent No.3 states that she has no objection to the application being allowed.
5. The application is, therefore, allowed and the legal representatives of Sh.Jagjit Singh Anand, namely Mr.Kulwant Kaur, Mr.Harminder Singh Anand and Ms.Manpreet Kaur are impleaded as respondent No.3 (i), (ii) & (iii) in this appeal. The amended memo of parties filed with the application is taken on record.
