CM APPL. 25541/2026 in MAC.APP. 204/2026 (for correction of order)

1. This application has been filed seeking correction of typographical error specifically in *paragraph no.1* of order dated 23rd March 2026, passed by this Court in **MAC.APP.204/2026**, where reference is to “*MACT No. 744/2021 with an award of Rs.18,24,272/- along with interest @ 9% per annum*”, which ought to be “*MACT No. 744/2021 with an award of Rs.*



97,07,651/-, along with interest @ 9% per annum till realization within 30 days, and further interest @ 12% per annum for the period beyond 30 days”.
