Hearing Through Video-Conferencing due to Covid-19

1. The original of issued bank guarantee bearing no. LG/6216/GT012836/17 dated 24th April, 2017 extended on 16th April, 2020 for a sum of Rs. 25,00,00,000/- (Rupees Twenty Five crores Only) which is valid upto 23rd October, 2020, is placed on record in e-form.
2. Mr. Vishal Satyam, Vice President with Bank of America NA (Bank.), 1st Floor DLF Centre Sansad Marg New Delhi 110 001, is present today. His statement recorded with regard to the said bank guarantee Ex. P1.
3. The statement of AR of petitioner company, Mr. Sanjeev Kumar Taku is also recorded separately.
4. I have seen both of them signing their statements, through video. Thereafter, they have e-mailed the scanned copy of signed documents to the stenographer, it be taken on record of the Court



file. Soft copy of the documents regarding their identity has been received by the reader and stenographer of the Court. I have also seen them and I am satisfied regarding their identity.

5. Having regard to the statement of Mr. Vishal Satyam and Mr. Sanjeev Kumar Taku, Bank Guarantee bearing no. LG/6216/GT012836/17 dated 24th April, 2017 extended on 16th April, 2020 for a sum of Rs. 25,00,00,000/- (Rupees Twenty Five crores Only) which is valid upto 23rd October, 2020, Ex.P1 is found in order and accordingly, the same is hereby accepted.
6. Learned counsel for petitioner submits that he could not file the said original bank guarantee in physical form due to its non-acceptance by the Registry. Registry is directed to accept the said original extended bank guarantee in physical form. I have seen the said bank guarantee, received via electronic mode, by the reader of my Court.
7. Registry is directed to put up this file at least two weeks before the date of expiry of any of the bank guarantee in case the petition is not finally disposed off by the date upto which the bank guarantee Ex. P1 is valid.
8. Learned counsel for the petitioner is directed to file the extended bank guarantee beyond the period of 23rd October, 2020, as early as possible.
