1. The present application has been filed on behalf of the appellant under Section 152 CPC read with Section 151 CPC for correction/modification of the Order dated 14th January, 2026.
2. Ld. Counsel for the Respondent enters appearance and accepts Notice, on being asked if he has any objection to the same, he submits that he has no objection if the instant application is allowed.
3. It is submitted by learned Counsel for the Applicant that, in the application moved on his behalf seeking release/return of the old bank guarantees being **CM APPL. 1228/2026**, the date of the bank guarantee was inadvertently mentioned as 16.07.2021, whereas the correct date of issuance of the bank guarantee is 24.03.2021. The date 16.07.2021 pertains only to the verification of the bank guarantee and not to its issuance.
4. In pursuance to which, relying upon facts stated in the said application, an Order dated 14.01.2026 was passed. However, in paragraph 6 of the said order, the date of the bank guarantee was inadvertently



incorrectly mentioned as 16.07.2021 in place of 24.03.2021, as per the application.

4. Considering the arguments advanced by the applicant coupled with documents placed on record, the error deserves to be rectified.

5. In view of the aforesaid, the corrected paragraph of the Order dated 14th January, 2026 shall now be read as hereunder:

“3. The Petitioner is seeking direction for substitution of the old Bank Guarantee of Rs. 25 Crores issued by Bank of America with the new Bank Guarantee of Standard Chartered Bank and for releasing/returning the original old Bank Guarantee dated 24.03.2021, 08.10.2020 along with original letter of amendments/renewed Bank Guarantees dated , 08.10.2021, 02.05.2022 and 22.09.2022. Learned counsel for the respondents has no objection to the same.”

6. Accordingly, Order dated 23rd March, 2026, stands corrected and the same shall be treated as part and parcel of the instant Petition.

7. It is further directed that all the earlier bank guarantees submitted by the Respondent be returned to him and bank guarantee no. **LG/6216/GT018016/23** for a sum of **Rs.25,00,00,000.00/-** (Rupees Twenty Five Crores Only) valid upto 30th September, 2026 shall be treated as the only bank guarantee.

7. The application is allowed and is accordingly disposed of.
