**CM APPL. 11688/2025 in LA.APP. 452/2009 (Seeking Amendment in Prayer)**

1. The present application has been moved under Order VI Rule 17 read with Section 151 CPC,1908 seeking amendment of the prayer clause in the



appeal filed by the Appellant, which presently reads as follows:

*“Allow the Applicant to amend the prayer of the appeal to read as follows: “The appeal may kindly be allowed, and the market value of the appellant's land be determined as ₹40,000/- per sq. mtr. for the land measuring 2462.34 sq. mtrs., along with statutory solatium and interest, thereby granting a decree for ₹9,84,93,600/-.”*

2. The present application is allowed, considering that the amendment sought by the Applicant/Appellant is limited to the prayer clause, namely with respect to the calculation of the compensation claimed and the incorporation of the land size/area/measures, which were not mentioned earlier.

3. Let the amended plaint be filed and, upon being so filed, be taken on record in accordance with law.

4. Accordingly, the said application is allowed.

**CM APPL. 1125/2023 in LA.APP. 55/2021 (Directions for Deposit of 50% of the Decretal Amount to the Appellant)**

5. The present application has been filed under Section 151 CPC, 1908 on behalf of Respondent No. 1 seeking the following reliefs:

*“It is therefore. most respectfully prayed that this Hon'ble Court may kindly be pleased to allow the present application and the amended judgment & decree dated 11.04.2022 along with the certified copy of Nazir report dated 10.10.2022 be taken on record.*

*It is further prayed that the appellant may kindly be directed to deposit the entire 50% of the decretal amount in terms of the order dated 24.08.2021 passed by this Hon'ble Court as well the amended judgment & decree dated 11.04.2022.”*

6. The present application is partly allowed to the extent of the prayer seeking to place on record the amended judgment and decree dated 11th



April, 2022 along with the certified copy of the Nazir Report dated 10th October, 2022. Let the same be taken on record.

7. Insofar as the other prayer seeking a direction to the Appellant to deposit 50% of the decretal amount in terms of the amended Judgment and decree is concerned, the same shall be considered at an appropriate stage.

8. List on 20<sup>th</sup> July, 2026.

**CM APPL. 8792/2025 in LA.APP. 55/2021 (For Amendment of Appeal)**

9. The present application has been moved on behalf of the Appellant/North Delhi Municipal Corporation under Order VI Rule 17 read with Section 151 CPC, 1908 seeking amendment in LA.APP. No. 55/2021.

10. Having considered the submissions made and the material on record, the present application is allowed.

11. Let the amended appeal be filed and taken on record.
