1. Both the suits are between the same parties. The plaintiff has filed these applications for adjournment of the suit *sine die* pursuant to a judgment dated 24.01.2023 passed in CS(OS) 655/2017 [*Doris Chung Gim Lian and Anr. vs. Shantanu Prakash and Ors.*]. By virtue of the directions contained in paragraph 46(xiii) of the said judgment, it has been directed that the plaintiff should not proceed further with these suits against the defendant-society.
2. Learned counsel for the defendant states that the aforesaid judgment has been carried in appeal by one of the parties, in which the Division Bench has issued notice and passed certain interim orders yesterday i.e. 09.02.2023.
