1. It is stated that the respondent/wife is lodged in Tihar Jail No. 6 in
FIR bearing no. 1475/2014, registered at Police Station Rajouri Garden,



New Delhi for the offences punishable under Sections 302 of the Indian Penal Code, 1860 ('IPC').

2. It is also stated that the petitioner is presently residing in Britain. Accordingly, both the parties are directed to appear before the Incharge, Delhi High Court Mediation and Conciliation Centre, Samadhan, (through Video Conferencing) on 03.03.2023 at 4.00 PM and try to amicably settle the remaining disputes between them. The Superintendent Jail will make arrangement for the same and ensure that respondent is allowed to appear through VC before the Mediation Centre.

3. The Incharge, Mediation will ensure that every possible endeavour is made to make the parties act on the settlement already arrived at *vide* Memorandum of Understanding dated 21.12.2009.

4. Re-notify the matter on 28.03.2023.

5. The order be uploaded on the website forthwith.
