1. Defendant No.1 is present in Court. Plaintiff No.1 is also present.



Defendant No.1 submits that the passport of his father Late Shri Harbhajan Singh Vedi is not available with him. Let an affidavit to this effect be filed by him. The defendant no.1 shall also file a copy of his entire passport in a sealed cover. Copy of the same would not be released to any of the parties till the next date.

2. Assistant Commissioner of Police, EOW Cell has filed a status report of the investigation, as per the last order. The said status report reveals that an FIR has been registered in this matter and investigation is continuing. The status report is taken on record. The police authorities are directed to continue with the investigation and put up a report with regard to the progress on the next date. Copies of the status report be made available from the Court record itself to Ld. Counsel for the parties.

3. Ld. Counsel for the Plaintiff submits that an affidavit has been filed in compliance with the last order. Let the same be traced and placed on record. Copies be supplied to the parties.

4. Notice be issued to Standing Counsel for Union of India. Mr. Arun Bhardwaj, Standing Counsel accepts notice on behalf of Union of India. He is directed to ascertain the details of the travels of Late Mr. Harbhajan Singh Vedi through airport authorities with respect to passport bearing No.Z2182419 as annexed with the affidavit filed by ICICI Bank, Patiala, especially for the period 1st January, 2013 till 31st December, 2015.

5. All the parties are permitted to obtain the electronic copy of the court record.
