- “a) direct the Petitioner Ajay Mohan Kapoor to deposit the fee and other expenses till he clears Class 12th Standard with J.M. International School, Sector-6, Dwarka, New Delhi.*
- b) Any other appropriate relief which this Hon'ble Court may deem fit and proper be also granted.”*

5.0 Issue notice.

6.0 Mr. R.P. Luthra, Ld.counsel for the petitioner appears on advance notice.

6.1 Ld. counsel for the petitioner submits that he is ready to make submissions on the present application.

7.0 Heard both the sides.

8.0 Admittedly, the minor child of the parties is presently studying in Class IX at present.

8.1 Ld. counsel for the petitioner submits that the demand of fee is raised by the school directly on the petitioner; and as and when such demand is raised, fee is paid in time. Ld. counsel for the petitioner also submits that the petitioner has been regularly paying school fee. **Ld. counsel further submits that the petitioner has already paid fee for the quarter of July to September 2022.** Ld. counsel for the petitioner also submits that a credit balance of Rs.12,278/- is still lying in the school account.

8.2 Ld. counsel has now handed over a copy of email received from school to the above effect. Ld. counsel submits that the said email was forwarded to him by the petitioner and makes statement at bar in

this regard. Same is taken on record.

9.0 Ld. counsel for the respondent no. 2 does not dispute that the child's fee till September 2022 has already been deposited.
