Crl. M.A. No. 5747/2017

Exemption, allowed subject to all just exceptions.

The application stands disposed of.

Crl. M.A. No.5648/2017 (U/S 482 Cr.P.C. filed by R-2)

Vide order dated 31.03.2017, it was ordered that the non-applicants will place on record the original documents, if the same are in their possession, till the next date of hearing i.e. 10.04.2017.

However, learned senior Advocate appearing for the petitioners submitted that they have not filed the documents and be given time to file the available documents within a week.

Respondent No.2 submitted that the same should be seized by the Police.

Let the original documents, if in possession, be filed within a week by the non applicants. Reply to the application be filed within four weeks. Rejoinder, if any, be filed within two weeks thereafter.

Crl. M.A. No. 4716/2017 (stay)

Respondent No.2 submitted that vide order dated 20.03.2017, the operation of the impugned order dated 06.02.2017 was directed to remain stayed till the next date of hearing, i.e., 21.09.2017, and requested to modify the same.

Reply not filed by the respondents.

Reply be also filed by respondents within four weeks. Rejoinder, if any, within two weeks thereafter.

Interim order to continue, till the next date of hearing.

Crl. M.A. No. 5746/2017 (recall of order dated 20.03.2017)

This is an application filed by respondent No.2, seeking recall of the *ex parte* stay order dated 20.03.2017.

Let reply be filed within four weeks with an advance copy to respondent No.2. Rejoinder, if any, be filed within two weeks thereafter.

CRL.M.C. 1143/2017

Respondents shall file reply, if any, within four weeks. Rejoinder, if any, be filed within two weeks thereafter.
