ORDER

1. This hearing has been done through hybrid mode.
2. The present appeal has been listed for hearing.
3. It has been brought to the notice of this Court that in a connected appeal by the complainant being **CRL.A.1340/2011**, it has been directed that the present appeal and the said appeal have to be heard together. The said order dated 24th August, 2012 reads as under:

“1. Heard learned counsels on this application filed by the appellant under Section 390 of the Code of Criminal Procedure praying that the respondent nos.2 to 4 be arrested and brought before the court.

2. It is noteworthy that apart from the present appeal, the State has also preferred Crl.L.P.No.10/2012 under Section 378(1) of the Code of Criminal Procedure. The respondent nos.2 to 4 have been summoned not only in the present appeal but also in Crl.L.P.No.10/2012 and have entered appearance before this court in answer thereto.

3. In terms of the order dated 6th July, 2012 recorded



in Crl.L.P.No.10/2012, the respondent nos.2 to 4 herein have furnished personal bond to the satisfaction of the Registrar General of this Court. The respondent nos.2 to 4 have therefore, entered appearance in the matter and have appeared on all dates fixed by this court.

4. These two matters arise out of the judgment dated 18th July, 2011 passed by the learned Trial Judge acquitting the respondents of the charges under Sections 302/304 of the IPC which have been framed against them.

In these circumstances, we are not inclined to grant the prayer to arrest the respondent nos.2 to 4 made in this application.

This application is therefore, dismissed.

Admit.

This appeal shall be heard along with Crl.L.P.No.10/2012 which is to be registered as an appeal.”

4. Let notice be issued to the complainant through the concerned IO.
5. The Registry to also issue court notice to Sh. Pradeep Kumar, the Appellant in **CRL.A. 1340/2011**.
6. Let the present appeal as also **CRL.A. 1340/2011** be listed on 12th August, 2026.
7. Let the appeals be listed before the same bench, as they arise out of a common judgment, subject to orders of Hon’ble the Chief Justice.
