IA No.18475/2022 u/O XXII R 4 CPC moved by plaintiff for bringing on record LR's of deceased defendant no.4; and IA No.18476/2022 moved by plaintiff seeking condonation of delay in filing IA No.18475/2022

Learned counsel for the proposed LR's of defendant no.4, who is also appearing on behalf of the proposed LR's of defendant no.2 and defendant no.5&6, submits that he will file Vakalatnama on behalf of the proposed LR's of defendant no.4 shortly. Let needful be done as stated.

Learned counsel for the proposed LR's of defendant no.4 is directed to file the Death Certificate of deceased defendant no.4 with the Registry within two weeks, with copy to opposite side.

At request, reply, if any, to captioned IA be filed by the proposed LR's of defendant no.2, proposed LR's of defendant no.4 and defendant no.5&6 within three weeks with copy to the opposite side, who is at liberty to file



rejoinder, if any, within two weeks thereafter with copy to opposite side.

It is stated by learned counsel for defendant no.1 to 3 that he has not received copy of captioned IA. So, learned counsel for the plaintiff is directed to supply copy of captioned IA to learned counsel for the defendant no.1 to 3 through e-mail within two days.

Thereafter, reply, if any, be filed by the defendant no.1 to 3 within three weeks with copy to the opposite side, who is at liberty to file rejoinder, if any, within two weeks thereafter with copy to opposite side.

Re-notify captioned IA for completion of pleadings/ consideration on the next date of hearing.

Pleadings in the suit qua defendant no.1 to 6 are already complete and the matter was listed for marking of exhibits to the documents.

However, an application for bringing on record the LR of defendant no.4 has been moved by the plaintiff, which is pending consideration.

Re-notify the matter for further proceedings on 17.04.2023.
