2. Learned senior counsels for the parties submit that the Cont.Cas(C) 800/2016 is listed before this Court on 25th October, 2018 and the pleadings in the main petition are complete. In that view of the matter, the main contempt petition and all pending applications shall be taken up for hearing at the end of the Board on 25th October, 2018, the date already fixed.
3. The brief note of submissions and the convenience compilation be filed by the parties at least three days before the next date of hearing.
4. The record of W.P.(C) No.11921/2016 be requisitioned for the next date of hearing.
5. Learned senior counsel for the petitioner seeks an interim injunction against respondents No.1 and 6. This prayer shall be considered on the next date of hearing. However, further actions of respondent no.1 and 6 shall be subject to final outcome of this petition. Respondent no.1 and 6 are directed to file the status report on affidavit on monthly basis with respect to the actions taken by them in a sealed cover.
