On 22.02.2018 this court had directed all Eastern Medikit Ltd. Employees Union to pay Rs.2,69,510/- to the applicants of CA No.1941/2013 within four weeks and upon payment they were to take over the machinery lying at the property at 547-L, Sector-37, Phase-II, Pace City, Gurgaon, Haryana.

Today, the learned counsel for the Eastern Medikit Ltd. Employees



Union submits that the payments have been made but, on inspection, they found that the machinery is completely wasted as substantial parts of the machinery have already been removed.

Let the OL carry out an inspection of the machinery and place on record a report. The representative of the Eastern Medikit Ltd. Employees Union may be present at the time of inspection. The OL will file report within two weeks from today.

Ms.Geeta and Mr.Krishan Kumar the applications in CA No.1941/2013 will give as agreed the sum of Rs.2,69,510/- back to the Eastern Medikit Ltd. Employees Union within two weeks from today. Thereafter, Ms.Geeta and Mr.Krishan Kumar are free to dispose of the machinery, if they wish to.
