1. The present writ petitions pertain to the challenge of the petitioner to the suspension order issued by the respondent, thereby suspending the petitioner herein. W.P.(C) 6148/2017 has been filed against the suspension order dated 28.06.2017. W.P.(C) 58/2018 has been filed against the recommendation of suspension against the

petitioner. W.P.(C) 7404/2018 has been filed for setting aside the extension of the suspension order against the petitioner.

2. It is pointed out by learned counsels appearing for the respondents that the petitioner has filed another writ petition being W.P.(C) 10478/2019 in which the substantive relief has been claimed by the petitioner for release of subsistence allowance and salary for the whole period of suspension. Thus, it is submitted that the present writ petitions are connected with the said the said writ petition, which is coming up for hearing before the Court of Hon'ble Ms. Justice Jyoti Singh on 24.05.2023. It is, thus, prayed that the present petitions may be listed along with W.P.(C) 10478/2019.

3. During the course of hearing, learned counsel appearing for the respondent No.1-DOE sought to serve copy of counter-affidavit in W.P.(C) 10478/2019. However, the petitioner refused to accept the same on the ground that the said matter is not listed today.

4. In view of the aforesaid, list the present writ petitions along with W.P.(C) 10478/2019, before the Court of Hon'ble Ms. Justice Jyoti Singh on the date already fixed i.e. 24.05.2023, subject to orders of Hon'ble the Chief Justice.
