1. Learned counsel appearing for the plaintiff draws the attention of this Court to the Settlement Agreement dated 12th October, 2023, with defendant nos. 7 and 8.
2. The matter was referred to Delhi High Court Mediation and Conciliation Centre, wherein, they have now successfully negotiated a settlement and executed a Settlement Agreement dated 12th October, 2023.
3. Learned counsel appearing for the plaintiff and defendant nos. 7 and 8, confirm the terms of the settlement, and pray that the suit be decreed in terms thereof.



4. The Court has perused the terms of the settlement and finds the same to be lawful.

5. In terms of the Settlement Agreement the defendants have acknowledged the Intellectual Property Rights of the plaintiff in the trademarks, as set out in the plaint as well as exclusive right of the plaintiff to reproduce, prepare derivative works of, and distribute copies of the NFPA copyrighted works.

6. Accordingly, the present suit is decreed in favour of the plaintiff and against defendant nos. 7 and 8, in terms of the Settlement Agreement dated 12th October, 2023, which shall form part of the decree.

7. The parties shall remain bound by the terms and conditions of the settlement.

8. Decree sheet be drawn up.
