1. The bailable warrant report of Mr. Gurmeet Singh Tony has not been received from the concerned SHO, Paschim Vihar, Delhi despite the office noting that it was duly received by the concerned SHO for 21.01.2025.

2. At this stage, one counsel has appeared for M/s Hindustan Co-operative House Building Society and seeks adjournment. He concedes that bailable warrants has been duly served on Mr. Gurmeet Singh Tony. He has not furnished any reason for his non appearance today. The requisite records have also been produced today. At this stage, learned counsel for M/s Hindustan Co-operative House Building Society seeks pass over for producing Mr. Gurmeet Singh Tony and also for producing the records.

At 3.15 p.m.

3. However, now none is present on behalf of Mr. Gurmeet Singh Tony and it is informed to me that counsel who appeared in the morning for M/s Hindustan Co-operative House Building Society has not given his appearance. In this view of the matter, issue non-bailable



warrants against Mr. Gurmeet Singh Tony, President of M/s Hindustan Co-operative House Building Society to be executed by the concerned SHO for the next date of hearing. The Show Cause Notice be also issued to concerned SHO for not sending the report of bailable warrant. In case of non service of non-bailable warrants, the SHO concerned is directed to appear in person to render the explanation.

At 3.22 p.m.

4. At this stage, Mr. R. K. Gupta (Mob.9810541778), learned counsel for M/s Hindustan Co-operative House Building Society with Mr. Gurmeet Singh Tony is present. This matter is pending disposal since the year 2007 and considerably delayed due to recalcitrant attitude of Mr. Gurmeet Singh Tony. So, I deem fit appropriate to impose cost of Rs.6000/- upon Mr. Gurmeet Singh Tony, President of M/s Hindustan Co-operative House Building Society to be deposited with Delhi High Court Legal Services Committee. At this stage, Mr. Gurmeet Singh Tony, President of M/s Hindustan Co-operative House Building Society undertakes to make all earnest efforts to trace out the summoned records and produce the same on the next date of hearing. In case he is not able to produce the same, a written reply be filed for the same by Mr. Gurmeet Singh Tony, President of M/s Hindustan Co-operative House Building Society. Mr. Gurmeet Singh Tony is bound down to appear on the next date of hearing with complete summoned records.

5. The non-bailable warrant issued against Mr. Gurmeet Singh Tony are kept pending till the next date of



hearing. The order for issuing show cause notice to the concerned SHO is recalled.

Re-notify the matter for remaining evidence of respondent no.2 on 28.04.2025.
