Learned counsels for the parties have stated that mediation proceedings have failed. Prior to the transfer of the case to the Hon'ble Court, the case was pending before the Court of learned ADJ-07, South-East, Saket Courts, New Delhi and after dismissal of the application of plaintiff under Order 33 CPC, written statement had been filed by defendant nos. 1 and 3 which was taken on record as per order of the learned ADJ dated 29.11.2018.

Learned counsel for the plaintiff has stated that he had also filed replication to written statement of defendant nos. 1 and 3. However, other defendants had not filed written statement.



Thereafter, the case was transferred to the Hon'ble High Court on ground of pecuniary jurisdiction as per the order of the learned ADJ dated 21.08.2019.

Perusal of the PDF/online record of the case file reveals that written statement of defendant nos.1 and 3 and replication of plaintiff to written statement of defendant nos. 1 and 3 have not been scanned. The concerned official of the Registry is directed to complete the PDF file in this regard.

The case is at the stage of admission/denial. Plaintiff is directed to file Joint Documents Schedule within four weeks with advance copy to the opposite parties. Both the parties are directed to take steps for filing original signed pleadings and hard copies of the documents on record atleast one week before the next date of hearing. Both the parties are directed to appear alongwith original documents for marking of exhibits on the documents on the next date of hearing. The concerned official is directed to complete the file in all respects before the next date of hearing.

Learned counsel for defendant nos. 1 and 3 has stated that one counsel Ms. Saloni Mahajan had appeared on behalf of defendant nos. 2(A) to 2(C) during the mediation. Court notice be issued to counsel Ms. Saloni Mahajan to appear in person on the next date of hearing.

Put up for admission/denial and for marking of exhibits on 21st April, 2023.
