Learned counsels for plaintiff and LR of respondent no.7 submit that LR of respondent no.7 have already been brought on record as IA No. 8164/2025 was allowed on 16.05.2025, hence the captioned IA has become infructuous. In view of the submission made, the captioned IA is disposed off as infructuous.
