3. In the opinion of this Court there is clear discrepancy between the memo of parties at page 3, and the “array of parties in relation to whose affairs directions are sought” at page 4 of the present petition.

4. Mr.Deepak Khosla, petitioner in person, initially submitted that, in his view, it would be contrary to law to implead the “proforma parties” named at page 4 of the petition as respondents in the present case, and relies for this purpose, on a judgement, dated 25th January, 2017 passed by a Division Bench of this Court in Company Appeal 01/2017, a copy of which is annexed as Annexure-2 to the present petition.

5. Prima facie, this Court is of the view that the present petition would not be maintainable unless, the proforma parties, named at page 4, are arrayed as respondents herein.

6. On this point of view being put to Mr.Khosla, he seeks a short adjournment to examine the legal position and make submissions in this regard.

7. Re-notify on 11th July, 2017, on which date other matters between the parties are already listed at 3:00 pm.
