1. The captioned IA is listed today for arguments.
2. Ld. Counsel for plaintiff has submitted that he has no objection if the captioned IA is allowed.

5. Perusal of record shows that written statement to the amended plaint was already filed on behalf of defendant no.2. The same be taken on record in terms of order passed today while disposing off IA No.42066/2024.
6. The plaintiff may file replication to the amended written statement of defendant no.2 as per law.
7. No written statement to the amended plaint has been filed on behalf of the remaining defendants. There is no appearance on behalf of the remaining defendants. It appears that statutory period for filing written statement to the amended written statement by the remaining defendants has already expired. Hence, their right to file the same stands closed.
8. Perusal of record shows that affidavit of admission/denial was already filed on behalf of defendants no.1(A) to (D).
9. Ld. Counsel for defendant no.2 has submitted that he has not filed affidavit of admission/denial of documents on behalf of defendant no.2. He has further submitted that affidavit of admission/denial has already been conducted in the present matter as recorded in the order dated 22.02.2017.
- 10.No reply to the captioned IA has been filed on behalf of defendants despite last opportunity.
- 11.Ld. Counsel for plaintiff has submitted that in view of the fact that amended written statement on behalf of defendant no.2 has come on record and hence, he needs time to take instructions from the plaintiff with respect to the captioned IA. Let appropriate steps be taken as per law.
- 12.Let the pleadings be completed as per law.



13.Re-notify the matter for completion of pleadings and further proceedings on **13<sup>th</sup> May, 2025.**
