CM APPL.42958/2022 is an application under Order 22 Rule 3 CPC filed by the applicants seeking their substitution as legal heirs of deceased appellant No.1, who is stated to have died on 09.06.2021. A copy of the death certificate is annexed to the application. The details of legal heirs of deceased appellant No.1 are mentioned in para 2 of the application.

CM APPL.42959/2022 is an application under Section 5 of the Limitation Act filed by the applicants seeking condonation of delay of 380 days in filing the application under Order 22 Rule 3 CPC.
