1. Learned counsel for LR's of defendant no.9 has already given his no objection on 30.08.2024. Learned counsel for LR's of defendant no.1, 2 and 3 submits that he has no objection, if the captioned IAs are allowed. Learned counsel for defendant nos. 4 to 6 have already given their no objection on 13.08.2024. Defendant nos. 7 & 8 stated to be ex-parte.

2. Considering the grounds mentioned in the captioned IA and no objection being given by the contesting defendants, the delay in re-filing IA No.36389/2024 is condoned and the legal heirs of deceased plaintiff no.1 are brought on record.
