IA No. 8641/2022 (u/S 151 CPC for summoning witnesses by the plaintiff) &

IA No. 8642/2022 (for exemption from filing certified copies moved by the plaintiff).

1. As per office noting, nothing fresh has been filed.
2. Ld. Counsel for plaintiff has submitted that witnesses as mentioned in para 2 of IA No.8641/2022 be summoned for next date of hearing. He has further submitted that names of said witnesses are already mentioned in the list of witnesses filed on behalf of plaintiff. He has further submitted that exemption from filing certified copies of documents has been sought on behalf of plaintiff in IA No.8642/2022 in respect of the documents which have been attached alongwith the application of witnesses i.e. IA



No.8641/2022 for summoning of the record.

3. Ld. Counsel for defendant has submitted that he does not want to file any reply to the captioned IAs and the captioned IAs may be disposed off as per law.
4. Heard. Record perused. In view of submissions of the parties, the captioned IAs stand allowed subject to filing of PF and diet money.
5. Both the captioned IAs stand disposed off accordingly.

1. The matter is at the stage of PE.
2. PW Mr. Ram Krishan Singh Gund, Sub-Registrar office Punjabi Bagh II-A, New Delhi-110041 is present.
3. PW Mr. Ram Krishan Singh Gund submits that part of the summoned record is not with his office and he has brought only the record, which is lying with his office for the year 2010.
4. Ld. Counsel for plaintiff has submitted that record for the year 2009 is also required in the present matter and the witness has been intimated about the details of said record.
5. At request of Ld. Counsel for plaintiff, PW Mr. Ram Krishan Singh Gund is discharged unexamined today and he is bound down to appear in person with relevant record for next date of hearing. Diet money paid.
6. Office noting further reveals that PF not filed and hence, notice could not be issued to the witnesses.



7. On filing of PF, issue fresh summons to the witnesses in terms of order dated 11.03.2022 for next date of hearing.
8. Summons be also issued to the witnesses as mentioned in para no.2 of IA No.8641/2022 on filing of PF and diet money, for next date of hearing.
9. Re-notify the matter for PE on **21st February, 2023.**
