I.A.No. 13911/2017 under Order 6 Rule 17 CPC filed by plaintiff

The above application has been by the plaintiff to summon the concerned official from Mahila Thana, Sonapat and S.P Office, Sonapat along with complaint No. 3654 dated 25.07.2015 filed against defendant and his family by one Ms. Sonia Dabas.

Counsel for the plaintiff states that defendant no.1 has been harassing the mother of the plaintiff and similar complaints in this regard was also filed by Ms. Sonia Dabas, who also suffer at the hands of defendant no.1.

I have perused the issues framed in this matter on 08.03.2017 which essentially relate to whether plaintiff is a coparcener of HUF by virtue of being the son of defendant no.1 and whether the plaintiff is entitled to have a share in the property mentioned in Schedule A & B belonging to HUF.

Perusal of above accordingly reveals that complaint sought to be summoned by the plaintiff has no bearing on the decision on the issues framed in the instant suit and is thus not relevant for adjudicating the instant suit. Accordingly, the application filed by the plaintiff is dismissed.

I.A.No. 14194/2017 filed by plaintiff under Order 7 Rule 14 r/w Section 151 CPC for filling additional documents on record

By way of instant application, the plaintiff seeks to bring on record translated copy of the Khatauni of Tehsil Rasulpur, Delhi and official Gazette notification dated 17.05.2017.

It is stated by counsel for the plaintiff that by way of Gazette notification dated 17.05.2017, the village Rasulpur where the subject properties are located has been converted to an urban area from a rural area. The matter is at the stage of plaintiff's evidence and the plaintiff has not yet tendered its evidence. No prejudice shall be caused to the defendant, if the said documents are brought on record.

Accordingly, the above application is allowed. The plaintiff is permitted to bring the said documents on record.

IA stands disposed of.
