**I.A. 5987/2024 under Order I Rule 10 of CPC moved by
plaintiff for impleading of proposed defendants**

1. It is stated by learned counsel for the plaintiff that he has deposited the previous cost of Rs.3000/- with Delhi High Court Legal Services Committee. He has placed on record copy of proof of cost in the court today. The same is taken on record.

2. Learned counsel for the defendant no.7&8 that he has not received copy of the captioned IA. So, learned counsel for the applicant has supplied hard copy of the same to learned counsel for defendant no.7&8 in the court today. Let reply to the captioned IA be filed by defendant no.7&8 within three weeks with copy to the opposite side, who is at liberty to file rejoinder, if any, within two weeks thereafter with copy to the opposite side.

3. Learned counsel for the defendant no.9 accepts notice of the captioned IA. At request, learned counsel for



the applicant/plaintiff has supplied hard copy of captioned IA to learned counsel for defendant no.9 today in the court. Let reply to the captioned IA be filed by defendant no.9 within three weeks with copy to the opposite side, who is at liberty to file rejoinder, if any, within two weeks thereafter with copy to the opposite side.

4. Learned counsel for the defendant no.11 also accepts notice of the captioned IA. At request, learned counsel for the plaintiff undertakes to supply copy of the captioned IA to learned counsel for defendant no.11 within two days through email. Thereafter, reply to the captioned IA be filed by defendant no.11 within three weeks with copy to the opposite side, who is at liberty to file rejoinder, if any, within two weeks thereafter with copy to the opposite side.

5. As per office note, PF not filed by the applicant for service of the captioned IA upon non-applicants as well as proposed defendants. Learned counsel for the plaintiff seeks one more opportunity in this regard. No plausible explanation is furnished for not complying the last order. So, cost of Rs.5000/- is imposed upon the plaintiff to be deposited with Delhi High Court Legal Services Committee and the last and final opportunity is granted to the plaintiff to take steps for issuance of notice of the captioned IA upon remaining defendants through counsel as well as to the other proposed defendants by all permissible modes on taking steps by the applicant/plaintiff, returnable for the next date of hearing.

6. At this stage, it is stated by learned counsel for the plaintiff that he has also filed another application under Order I Rule 10 CPC vide diary no.1771074. However, no



such application is on record. Learned counsel for the plaintiff is at liberty to proceed as per law.

Re-notify the captioned IA for completion of pleadings/service on 26.05.2025.
