1. The reply to the above captioned IA filed on behalf
of defendant no. 15 is still lying under objections.
Necessary steps be taken by the defendant no. 15 to bring



the same on record, the next date of hearing. Rejoinder thereto, if any, be filed within three weeks with copy to the opposite side.

2. Learned respective counsels for the defendant no. 7&8,9&11 already submitted on the last date of hearing that no reply to the above captioned IA shall be filed and an argument shall be straightaway.

3. Neither vakalatnama nor reply to the captioned IA has been filed on behalf of proposed defendant no. 17 and no one is present on behalf of the said proposed defendant to explain in this regard.

4. Status Report filed on behalf of proposed defendant no. 19/the then, SHO, PS Prem Nagar is on record.

5. As per office note, again no steps have been taken by the plaintiff for service of the un-served LR's of defendant no. 1 & 20 nor an application for dropping defendant no. 12&14 has been filed till date.

6. Appropriate application, if any be filed, by the plaintiff within three weeks with copy to the opposite side.

8. The applicant/plaintiff is again directed to comply the provision, as directed vide order dated 26.05.2025 before the next date of hearing.



9. Re-notify the captioned IA on the next date of hearing.

I.A. 5987/2024 under Order I Rule 10 of CPC moved by plaintiff for impleading of proposed defendants

10. The reply to the above captioned IA has been filed on behalf of defendant no. 15 is still lying under objections. Appropriate application may be filed, by the plaintiff within three weeks with copy to the opposite side.

16. Learned counsel for the defendant no. 7 & 8 today submits that as per information received, defendant no. 10/Mrs. Meena Devi has expired and the last date of hearing he submitted that defendant no. 10/Mr. Panna Lal had expired. Let, necessary steps be taken by the plaintiff to move appropriate application, before the next date of hearing.

17. Re-notify the above captioned IA for completion of service/pleadings on the next date of hearing.
