1. It is stated by learned counsel for the appellants that the final arguments in the lead matter being LA. APP.59/2007 titled ***Bed Ram v. UOI & Anr.*** along with other connected matters have already been heard and judgment has been reserved in those matters by a Coordinate Bench of this Court. It is further submitted that the present matters listed herein arise out of the same notification and the quantum of compensation and enhanced compensation granted by



learned Reference Court is same as that of LA APP. 59/2007 and therefore, the outcome of LA. APP. 59/2007 and connected matters will have a direct bearing on the adjudication of the present appeals.

2. Learned counsels appearing on behalf of the respondents state that the batch of matters reserved by the Coordinate Bench of this Court, though related to the same notification, amount of compensation and the enhanced compensation granted by learned Reference Court but the present batch of matters relate to different villages and are covered by distinct awards. It is further stated that the respondents are also inclined to advance arguments in the present matters once the judgment in LA.APP. 59/2007 and connected matters is pronounced by the Coordinate Bench.

3. In view of the above submissions, at request, list these appeals for arguments on 3rd December, 2025.
