- [1]** Heard Mr. R. Ali, the learned counsel for the applicant.
- [2]** As per Office Note dated 02.03.2026, notice to respondent No.1 has been received back un-served with postal remark "Addressee left" which has been placed for record. Notice to respondent No. 2 has been received back un-served with postal remark "Addressee expired" which has been placed for record. Service report has been received back in respect of respondent No. 3 from Munsiff In-charge, Kamrup (M) stating that the respondent refused to accept the notice. Notice to respondent No. 4 has been
