Heard Mr. MD. M. S. Ali, learned counsel for the applicants.

2. This is an application praying for impleadment of following persons/officers- i)Shri Bhadesh Deka, the Director of Pension Assam

Housefed Complex Dispur, Guwahati-6, ii)Shri Tapan Kalita, District Elementary Education Officer, Kamrup, Amingaon and iii)Shri Munindra Goswami, Block Elementary Education Officer, Kamalpur, Pro-Baihata as alleged contemnors in the connected contempt petition being Cont.Cas(C) No.207/2020.

3. Having considered that the earlier alleged contemnors who have been arrayed as parties had reportedly either transferred or retired, and the above 3(three) officers ought to be impleaded are stated to be the present incumbents, I deem it appropriate to allow this application as they appear to be necessary parties in the contempt petition.

4. Accordingly, i)Shri Bhadesh Deka, the Director of Pension Assam Housefed Complex Dispur, Guwahati-6, ii)Shri Tapan Kalita, District Elementary Education Officer, Kamrup, Amingaon and iii)Shri Munindra Goswami, Block Elementary Education Officer, Kamalpur, Pro-Baihata are allowed to be impleaded as alleged contemnors in the Cont.Cas(C) No.207/2020.

5. The interlocutory application stands allowed and disposed of.
