**ORDER**

Heard Mr. M Ahmed, the learned counsel appearing for the petitioners. Also heard Mr. D Borah, the learned Senior Standing Counsel, DRI.

2. This is an application under Section 528 of the BNSS, 2023 in respect of NDPS Case No. 157/2025 arising out of DRI Case No. 24/CL/NDPS/METH/DRI/GZU/2024-25 pending in the Court of the learned Addl. Sessions Judge No. 1, Kamrup (M) at Guwahati.
3. The petitioners, namely, 1. Khairul Hussain & 2. Altaf Hussain have been shown as absconders in the charge sheet and therefore, the learned trial court issued Non-Bailable Warrant of Arrest against them.
4. The learned counsel for the petitioners has submitted that earlier the petitioners were granted bail during the period of investigation and during that period their bail application was rejected.
5. The learned counsel for the petitioners has submitted that the petitioners are interested in facing the trial and therefore, they should be given an opportunity to that effect.
6. I have considered the submissions made by the learned counsels of both sides.
7. Since the petitioners are interested in facing the trial, they deserve to be given an opportunity to face the trial. Therefore, their bail application is allowed.
8. It is hereby directed that the petitioners, namely, 1. Khairul Hussain & 2. Altaf Hussain shall appear before the Court of the learned Addl. Sessions Judge No. 1, Kamrup (M) at Guwahati in connection with NDPS Case No. 157/2025 on 02.02.2026. On their appearance, the petitioners, namely, 1. Khairul Hussain & 2. Altaf Hussain shall be released on bail of ₹50,000/- each with sureties of like amount to the satisfaction of the learned Addl. Sessions Judge No. 1, Kamrup (M) at Guwahati.
9. It is further directed that the petitioners shall regularly appear before the trial court on each and every date of hearing. If they fail to appear, the learned trial court shall be at liberty to procure their attendance in accordance with the procedures as laid down by law.
10. With the aforesaid direction, the criminal petition stands disposed of.
