Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

Perusal of the office note dated 21.04.2025 reveals that notice was issued to the respondent Nos. 2, 3 & 4 by registered post with A/D as well as by usual Court process on 06.03.2025 & 25.02.2025 respectively.

Now, in respect to the aforesaid notices issued to the respondent Nos. 2, 3 & 4, it has been observed as follows:—

In respect of the notice issued through usual Court process:— In this regard, it appears that the process server's reports have not been received by the concerned section as of yet.
