Heard Shri A. Rahman, learned counsel for the petitioner, who is aggrieved by a judgment dated 16.10.2026 passed by the learned Assam Board of Revenue in Case No.53(RA)/DBR/2022 instituted by the present respondent no. 5. The said appeal was preferred against an order dated 10.11.2022 in respect of the mutation of a plot of land.

Let notice be issued, returnable on 01.04.2026.

Ms. P.R. Mahanta, learned Standing Counsel, Revenue Department accepts notice on behalf of the respondent no. 1 and Shri N. Das, learned State Counsel accepts notice on behalf of the respondent nos. 3 & 4. Extra copies of the writ petition be served upon the learned counsel for the respondents during the course of the day.

Petitioner to take steps for service of notice upon the respondent nos. 2 & 5 by speed post with A/D. Steps within two days.

Shri Rahman, learned counsel for the petitioner prays for an interim order.

Considering that this judgment impugned is of October, 2025, this Court is not inclined to pass any blanket interim order. However, it is provided that till

the returnable date, no third party rights be created in respect of the land in question.
